



## **Instructions for CIRCULATORS of Nominating Petitions**

1. Circulators **MUST** be 18 years of age or older, and citizens of the United States
2. Circulators do not need to be registered to vote or even live in Illinois
3. Circulators **MAY NOT** circulate petitions for more than one political party. But circulators **may** circulate for more than one Republican candidate.
4. Circulators may sign **ONLY ONE** petition they circulate for DOUG BENNETT FOR CONGRESS
5. Circulators **MUST** personally appear and sign the circulator's oath in front of a notary public licensed in Illinois. Most banks and libraries will notarize a petition free of charge.
6. Petitions with fewer than 15 voter signatures **DO** count.
7. Do **NOT** cross out names. If you learn they are invalid make a note on a separate page
8. Do **NOT** fill out, or sign the bottom of the petition until you are in front of a Notary Public
9. Blank spaces in the circulator's affidavit should be completed with the exception of page number. Do **NOT NUMBER** the petition sheets.

## **Instructions for SIGNERS of Nominating Petitions**

1. Signers must live in and be registered to vote in the Illinois 10<sup>th</sup> Congressional District.
2. Signers may sign petitions for more than one Republican candidate.
3. You **MAY NOT** sign petitions for candidates of more than one political party in the same election (e.g., signing a petition sheet for a Republican for Congress and a petition sheet for a Democrat for Senator).
4. Petition signers do not need to have voted in a previous Republican Primary to be eligible to sign petition.
5. You **MUST** sign your name as it appears on your voter's registration card. For example, "William E. Jones" not "Bill Jones."
6. DO **NOT** use ditto (" ") marks for any part of an address.
7. You **MUST** use the address where you are registered to vote. Post Office Boxes are not acceptable.
8. Signers **MUST** sign in the presence of the circulator.
9. Petition signers **MUST** only sign for themselves. They **MAY NOT** sign for spouses, family members, or others.
