

**INSTRUCTIONS FOR CIRCULATORS OF NOMINATING PETITIONS
RANDY HULTGREN FOR CONGRESS**

1. *Circulators* **MUST** be 18 years of age or older and citizens of the United States.
2. All *signers*, but **NOT** *circulators*, **MUST** be registered to vote at the address of their residence in the 14th Congressional District of the State of Illinois.
3. *Circulators* **MAY NOT** circulate petitions for more than one political party (e.g., circulating a petition for a Republican for Governor and a Democrat for Congress is prohibited). *Circulators* **MAY** circulate petitions for more than one Republican candidate.
4. *Circulators* **MAY** sign only one petition they circulate for RANDY HULTGREN for Congress.
5. *Circulators* **MUST** personally appear and sign the circulator's oath and a notary seal stamped on the petition by a notary public licensed in Illinois. Most banks and public libraries will notarize a petition free of charge.
6. Petitions with fewer than ten (10) voter signatures **DO** count. If you are not able to fill the petition, you should still send in the partially filled petition. Each signature counts towards the required amount.
7. Blank spaces in the circulator's affidavit **SHOULD** be completed with the exception of the page number. **DO NOT NUMBER THE PETITION SHEETS.**

**INSTRUCTIONS FOR SIGNERS
OF NOMINATING PETITIONS**

1. *Signers* must live and be registered to vote in the Fourteenth Congressional District of the State of Illinois.
2. *Signers* **MAY NOT** sign petitions for more than one political party (e.g., signing a petition for a Republican for Governor and a petition for a Democrat for Congress is prohibited). *Signers* **MAY** sign petitions for more than one Republican candidate.
3. Petition *signers* do not need to have voted in a previous Republican Primary to be eligible to sign the petition.
4. All petition *signers* **MUST** sign in the presence of the *circulator*.
5. Petition *signers* may **NOT** sign the petition more than once.
6. Petition *signers* **MUST** sign only for themselves. They **MAY NOT** sign for spouses, family members or others.
7. Petition *signers* **SHOULD** sign their names as listed on their voter's registration card. For example, "William E. Jones" not "Bill Jones".
8. The petition *signers* **SHOULD SIGN AND NOT PRINT THEIR NAMES** unless that is the way they signed their voter's registration card.
9. **DO NOT** use ditto (" ") marks for any part of an address.
